**ORDER DIRECTING NOTICE AND
SETTING INTERVENTION DATE**

On July 23, 2010, Union Electric Company, d/b/a AmerenUE submitted a proposed tariff sheet designed to implement an adjustment to its Fuel and Purchased Power Clause. The tariff sheet has an effective date of September 23, 2010.

As required by Commission rule 4 CSR 240-20.090(4), the Staff of the Commission shall submit a recommendation regarding the proposed adjustment no later than August 22. Because August 22 falls on a Sunday, Staff must file its recommendation no later than Monday, August 23. No later than September 21, the Commission shall either: (1) issue an interim rate adjustment order approving the proposed tariff sheet; (2) allow the proposed tariff sheet to go into effect by operation of law; or, (3) reject the tariff. To this end, the Commission will issue notice, set an intervention deadline and direct Staff to file a recommendation.

Through Commission rule 4 CSR 240-3.161(10), parties in AmerenUE's rate case, File No. ER-2008-0318, establishing the rate adjustment mechanism, are made parties in this case without having to seek intervention. The Commission therefore acknowledges their status and will direct the Commission's Data Center to add those parties to the service list.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve a copy of this order upon the county commission of each county within Union Electric Company, b/d/a AmerenUE's service area, and upon the corresponding body in the City of St. Louis.
2. The Commission's Data Center shall add all parties in File No. ER-2008-0318 to the service list for this case.
3. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing AmerenUE's service area and to the news media serving therein.
4. Application's to intervene shall be filed no later than August 9, 2010, with:

5. The Staff of the Missouri Public Service Commission shall file, no later August 23, 2010, a recommendation regarding its examination and analysis of AmerenUE's proposed tariff sheet.
