On February 9, 2024, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty (Liberty or "the Company") filed proposed tariff sheets requesting a general rate increase. Liberty proposed a test year of the twelve months ending December 31, 2022, and further proposed the test year be updated through December 31, 2023. The Company did not request a true-up process.

On March 13, 2024, the Staff of the Commission (Staff) filed its response to Liberty's test year proposal. Staff's response did not object to the test year. No other responses to Liberty's proposed test year were received.

The Commission finds the unopposed proposed test year to be reasonable and will establish it as the test year, without a true-up.

THE COMMISSION ORDERS THAT:

1. The test year shall be the twelve month period ending December 31, 2022, updated through December 31, 2023.

2. This order shall be effective upon issuance.
