NOTICE OF COMMUNICATION

Issue Date: March 22, 2024

This notice is to memorialize communications by the Secretary of the Commission/Chief Regulatory Law Judge with Brett Felber and with the Clerk of the Missouri Court of Appeals-Eastern District.

On March 20, 2024, it came to the Secretary’s attention that Mr. Felber had contacted the Commission’s Data Center about filing a Notice of Appeal in the above-captioned case. It was brought to the Data Center employee’s attention that a form on the Commission’s internet page incorrectly stated that a Notice of Appeal and filing fee should be given to the Commission’s Data Center for processing. Mr. Felber had also attempted to contact the Court of Appeals and was similarly given the same incorrect information.

On March 21, 2024, the Secretary called the Clerk of the Missouri Court of Appeals-Eastern District and referred the Clerk to the change in procedures in Section 386.510, RSMo, which was amended effective August 28, 2019. The Clerk indicated that the Court’s procedures would be updated.

Following the call to the Clerk, on March 21, 2024, the Secretary called Mr. Felber and explained that the procedures had been corrected.
