**ORDER DIRECTING A STAFF TARIFF RECOMMENDATION
AND SETTING TIME FOR RESPONSES**

On March 22, 2024, The Empire District Electric Company d/b/a Liberty filed a tariff sheet to correct an error in a previously approved tariff sheet. Liberty’s tariff sheet bears an effective date of April 21, 2024. The Commission will direct its Staff to examine the tariff sheet and file a statement about whether it corrects the error and complies with the Commission’s September 14, 2023, order approving Liberty’s MEEIA extension. The Commission will also set a deadline for any responses to Liberty’s tariff sheet.

THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation about Liberty’s tariff sheet no later than April 4, 2024.
2. Any other responses to Liberty’s tariff sheet must be filed no later than April 4, 2024.
3. This order is effective when issued.
