## ORDER SETTING PROCEDURAL CONFERENCE

On March 8, 2024, the Commission issued its *Order Directing Filing of Joint Proposed Procedural Schedule*, in which it directed the parties to collaborate in order to reach a joint proposed procedural schedule to be filed by the Staff of the Commission (Staff) no later than March 22, 2024.

On March 22, 2024, Staff filed *Staff Response to Order Directing Filing of Joint Proposed Procedural Schedule and Motion for Procedural Conference*. In its response/motion, Staff requests that a procedural conference be held, due to the total number of parties and the number of parties without legal representation.

The Commission will grant Staff's motion.

### THE COMMISSION ORDERS THAT:

1. The parties shall appear by video or phone at a procedural conference to be held on Monday, April 8, 2024, beginning at 1:00 p.m. via WebEx. 2. Any party who cannot participate in the procedural conference, but would like to provide input as to the date of the evidentiary hearing and other procedural dates, shall contact Staff counsel<sup>1</sup> prior to the procedural conference.

3. Failure of a party to participate in the procedural conference, or to contact Staff prior to the conference to provide input, will be considered by the Commission as consent by that party to allow the other parties to provide the appropriate and necessary procedural schedule dates.

4. Failure to appear for the procedural conference by a party will not be considered by the Commission as grounds for dismissal of the party or the party's application, pursuant to Commission Rule 20 CSR 4240-2.090(5).

5. This order is effective when issued.
