UNOPPOSED MOTION TO SCHEDULE WITNESS FOR CROSS-EXAMINATION ONE BUSINESS DAY PRIOR TO SCHEDULED EVIDENTIARY HEARING DATE

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Company" or "Ameren Missouri") and for its unopposed motion to allow cross-examination of Company witness Jeffrey R. Holmstead on Friday, April 12, 2024, states as follows:

- 1. The evidentiary hearing in this case is scheduled to begin on Monday, April 15, 2024, and to continue through Friday, April 19, 2024. The Company's initial discussions with the Staff regarding proposed hearing dates had originally contemplated hearings the week of April 8, 2024, which was a week when all the Company's witnesses were available. However, to accommodate other case schedules that in particular impacted the Staff, the dates were moved back to the week of April 15.
- 2. It has since come to the Company's attention that one of its witnesses, Jeffrey R. Holmstead, is unavailable to testify the week of April 15 due to his responsibilities for his son's wedding, which is occurring out-of-town that same week.
- 3. The Company has contacted all parties, all of whom have indicated that they have no objection to having Mr. Holmstead take the witness stand for cross-examination on Friday, April 12, 2024. One party will need to examine Mr. Holmstead via Web-Ex or other appropriate means on that date.
- 4. Given Mr. Holmstead's conflict, the Company respectfully requests that his cross-examination be scheduled for 9 a.m., Friday April 12, 2024, at 9:00 a.m., and that the parties be

provided a Web-Ex link and number so that counsel for at least one party can conduct the crossexamination remotely. The Company respectfully suggests that the remainder of the evidentiary hearing schedule need not be impacted.

WHEREFORE, the Company requests that the Commission enter its order scheduling witness Holmstead's cross-examination at 9:00 a.m., Friday, April 12, 2024, and establish a Web-Ex link for use by the parties on the time and date.
