ORDER ACCEPTING STAFF REPORT AND CLOSING CASE

On March 29, 2022, the Staff of the Commission (Staff) requested the opening of an investigation into Spire Missouri, Inc. d/b/a Spire's (Spire) compliance with the Commission's gas safety rules. Staff was concerned that the timeliness of Spire's efforts to locate and mark its natural gas pipelines to prevent damage to those pipelines by excavators (commonly referred to as locates) has been declining in recent years. Staff's request was granted in the opening of this file.

On January 31, 2024, Staff filed its Investigation Report (Report). The Report identified violations of Section 319.030, RSMo (2016), and violations of the Commission's pipeline safety standards rule, 20 CSR 4240-40.030. The Report also set out recommendations related to the violations of the Commission's pipeline safety standards. Staff stated it would address the violations and recommendations in a forthcoming complaint case it will file against Spire.

On March 8, 2024, Spire responded stating that it generally agrees with Staff's recommendations. Spire also noted it has added a second locate vendor which has increased locate timeliness.

No other party has responded to the Report, or to Spire's response to the Report.¹ The Commission will accept Staff's Report and close this file.

- 3. This file shall close on March 28, 2024.
