**FINDING OF NECESSITY AND ORDER DIRECTING THAT THE  
PROPOSED RULE AMENDMENTS BE FILED FOR PUBLICATION**

The Commission has undertaken this rulemaking to modify the Commission's rules regarding Intervention. The amendment clarifies that a potential intervenor must state with specificity the reasons it seeks intervention and if it cannot state a position, must explain why it cannot do so and when it expects to be able to take a position.

The Commission finds that the rule amendments are appropriate and necessary to protect the public interest and to carry out the purposes of the statute that granted the Commission authority to regulate in this area.

The Commission will seek further comments from interested stakeholders during the rulemaking process.

**THE COMMISSION ORDERS THAT:**

1. The Secretary of the Commission shall file the proposed amendments with the Secretary of State for publication in the Missouri Register.

2. This order shall be effective when issued.
