LIBERTY'S PROPOSED PROCEDURAL SCHEDULE

COMES NOW Liberty Utilities (Midstates Natural Gas) d/b/a Liberty ("Liberty" or "Company"), by and through undersigned counsel, propose the following procedural schedule:

- 1. The test year of the 12 months ending December 31, 2022 was established for this case. See Commission's Order Establishing Test Year, issued and effective March 21, 2024, at ordering paragraph 1. As explained in Company witness Charlotte Emery's direct testimony, at page 5, lines 5-7, and at page 8, lines 17-20, the test year ending December 31, 2022 was used as the basis for the general rate change requested by the Company, and adjustments had been proposed for known and measurable changes to the test year that will be updated through December 31, 2023.
- 2. Commission Staff and the Office of Public Counsel ("OPC") have already begun propounding data requests ("DRs") to the Company, and many seek cost data beyond the test year including cost data from 2023. The Company will provide actual cost data from the 12 months ending December 31, 2023 as they are available in response to DRs. However, the Company will need time to incorporate the actual 2023 financial data into its revenue requirement models following close of 2023 books.

- 3. Liberty is in the process of finalizing or "closing" its books for the year ended December 31, 2023, and it will not be possible for Liberty to update its discrete adjustments for the December 31, 2023 update period by April 30, 2024, as proposed by the Non-Liberty Parties.
- 4. Therefore, Liberty recommends that the Commission adopt the following Procedural Schedule, which is the same as the proposed procedural schedule being filed by Staff, OPC, and the Missouri School Board Association ("MSBA") (collectively "Non-Liberty Parties"), with one exception regarding the date for Liberty to provide the updated revenue requirement models. Liberty proposes to update the pro forma adjustments using actual data through December 31, 2023 by mid-2nd quarter 2024 (between May 17 June 3, 2024), rather than April 30, 2024, as proposed by the Non-Liberty Parties.
- 5. Since the Liberty updated information will only be discrete items, the Non-Liberty Parties will not be prejudiced by a later filing date for this information. Under Liberty's proposed procedural schedule, the Staff and Public Counsel will still have one-month to review Liberty's discrete updated adjustments before the Staff and Public Counsel's Direct Testimony for the Revenue Requirement issues will need to be filed on July 18, 2024.
- 6. The other provisions related to the scheduling of local hearings, technical and settlement conferences, discovery conditions, and other procedural rules being proposed by the Non-Liberty Parties are acceptable to Liberty.
- 7. For the reasons stated herein, Liberty respectfully requests that the Commission adopt the following procedural schedule:
