RE: Advance Notice of Southwestern Bell Telephone Company of Change of Corporate Structure and Name.

Dear Secretary/Judge Dippell:

This letter shall serve as advance notice to the Missouri Public Service Commission (hereinafter the “Commission”), pursuant to 20 CSR 4240-28.011(2), that on and effective May 1, 2024, Southwestern Bell Telephone Company, a Delaware corporation properly registered and authorized to do business in the state of Missouri as a foreign corporation, will convert to a Delaware limited liability company and change its name to Southwestern Bell Telephone Company, LLC.

Due to the nature and timing of the conversion transaction that will occur on May 1, 2024, Southwestern Bell Telephone Company is unable to provide the documentation required by 20 CSR 4240-28.011(2)(A)2. as of the date of this advance notice filing. Following the Delaware conversion, Southwestern Bell Telephone Company, LLC, upon the filing and receipt of the registration documentation from the Missouri Secretary of State, will promptly provide all the registration documentation to the Commission in this proceeding. Southwestern Bell Telephone Company, LLC, like its predecessor, will do business in the state of Missouri as AT&T Missouri, a registered fictitious name. The registration documentation for the fictitious name filing will also be provided to the Commission in this proceeding upon its receipt from the Missouri Secretary of State.

As required by 20 CSR 4240-28.011(2)(A)3., Southwestern Bell Telephone Company has reviewed and, if necessary, updated the company’s contact information in EFIS.

Pursuant to the requirements of 20 CSR 4240-28.011(2)(B), attached hereto as “Attachment A” and made a part hereof by this reference, are the following Southwestern Bell Telephone Company, LLC, tariff filings to be effective May 1, 2024:

- new Southwestern Bell Telephone Company, LLC d/b/a AT&T Missouri - General Exchange Tariff (P.S.C. MO. No. 1) superseding and replacing the Southwestern Bell Telephone Company d/b/a AT&T Missouri - General Exchange Tariff (P.S.C. MO. No. 1) in its entirety;



- new Southwestern Bell Telephone Company, LLC d/b/a AT&T Missouri - Local Access Tariff (P.S.C. MO. No. 3) superseding and replacing the Southwestern Bell Telephone Company d/b/a AT&T Missouri - Local Access Tariff (P.S.C. MO. No. 42) in its entirety;
- new Southwestern Bell Telephone Company, LLC d/b/a AT&T Missouri - Wireless Carrier Interconnection Service Tariff (P.S.C. MO. No. 2) superseding and replacing the Southwestern Bell Telephone Company d/b/a AT&T Missouri - Wireless Carrier Interconnection Service Tariff (P.S.C. MO. No. 40) in its entirety; and,
- notice of Southwestern Bell Telephone Company, LLC d/b/a AT&T Missouri adopting the Southwestern Bell Telephone Company d/b/a AT&T Missouri -- P.S.C. Mo. - No. 36 ACCESS SERVICES TARIFF in its entirety with revisions to reflect the legal change in name and the issuing of Tariff F.C.C. No. 1, following the cancellation of Southwestern Bell Telephone Company Tariff F.C.C. No. 73.

The conversion transaction will be seamless and transparent to Southwestern Bell Telephone Company customers. The only change customers will see is the service provider name on their AT&T bill. Customers' services, rates, terms, and conditions, for those services will not be affected.
