The Commission promulgated a final order of rulemaking on November 16, 2023 for 20 CSR 4240-40.030, which became effective on March 30, 2024. Section 536.200, RSMo, requires a review of the fiscal costs to public entities of this rule at the end of the first full fiscal year after implementation of the rule. Thus, the Commission will order its Staff to conduct such fiscal review and file the results.

### THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file the results of its public entity fiscal cost review of this rule no later than August 29, 2025.

2. This order shall be effective on April 1, 2024.
