ORDER SETTING TIME FOR RESPONSES

On March 29, 2024, the Commission’s Staff filed its *Motion to Strike Portions of the Surrebuttal Testimony of Ameren Missouri Witness Matt Michels and Motion for Expedited Treatment*. Staff asks that the Commission strike portions of the pre-filed surrebuttal testimony of Union Electric Company d/b/a Ameren Missouri witnesses Matt Michels. In support of its motion Staff asserts that Matt Michels’ testimony is improper because it includes information that should have been presented in Ameren Missouri’s direct testimony. Additionally, Matt Michels’ surrebuttal testimony includes an extensive number of workpapers related to the testimony Staff seeks to strike.

Ameren Missouri filed a response opposing Staff’s motion on April 1, 2024. Ameren Missouri asserts that Matt Michels’ surrebuttal testimony did not introduce new information that should have been included in its direct and was instead responsive to rebuttal testimony.

Staff argues that because of the short amount of time remaining before the evidentiary hearing it does not have the resources to review the material in Michels’ surrebuttal testimony. Staff also states that it does not believe that allowing for additional Staff sur-surrebuttal testimony is a sufficient remedy.

The Commission will set a deadline for other parties to file responses to Staff's motion to strike. The Commission will not rule on Staff's motion to strike portions of Matt Michels' surrebuttal testimony at this time.

THE COMMISSION ORDERS THAT:

1. Any responses to Staff's motion to strike must be filed no later than April 8, 2024.
2. This order is effective when issued.
