On April 3, 2024, Green Hills Area Cellular Telephone, Inc. d/b/a Green Hills Telecommunications Services filed its application for expansion of its designation as a wireless Eligible Telecommunications Carrier. The Commission will direct its Data Center to issue notice of the application, set a deadline for requests to intervene, and direct the Staff of the Commission to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall send notice of this application to all local exchange carriers certificated to provide service in Missouri.
2. Requests to intervene shall be filed with the Commission no later than April 19, 2024.
3. The Staff of the Commission shall file a recommendation no later than May 6, 2024.

4. This order shall be effective when issued.
