## SECOND ORDER TO SHOW CAUSE

The Commission set a prehearing conference for January 18, 2024. The applicants, Jack and Tammy Duncan, failed to appear. The Commission issued a show cause order on February 26, 2024, asking applicants to explain their failure to appear. Applicants did not respond.

Commission Rule 20 CSR 4240-2.116(3) states that a party may be dismissed for failure to appear at a prehearing conference. The Commission will again order the applicants to show cause why their application should not be dismissed or to state if the applicants wish to have their application dismissed. Failure to respond may result in dismissal of the application for good cause pursuant to Commission Rule 20 CSR 4240-2.116(4).

### THE COMMISSION ORDERS THAT:

1. The applicants, Jack and Tammy Duncan, shall respond as ordered above no later than March 18, 2024.

2. This order shall be effective when issued.
