**BACKGROUND**

1. On March 21, 2024, the Missouri Public Service Commission (“Commission”) issued its *Order Establishing Procedural Schedule* (“Order”).
2. The Office of the Public Counsel (“OPC”), Staff (“Staff”) for the Commission, and the Company have discussed the ordered schedule and request the following modifications:


