### ORDER APPROVING TARIFF REVISION

On March 22, 2024, The Empire District Electric Company d/b/a Liberty filed a tariff sheet to correct an error on Sheet No. 21d and bring the tariff sheet into compliance with the Commission approved Stipulation and Agreement extending Liberty's Missouri Energy Efficiency Investment Act Cycle 1 an additional year. That tariff sheet bears an effective date of April 21, 2024. The Commission ordered its Staff (Staff) to file a recommendation about the tariff sheets and set a deadline for responses. Staff filed a recommendation to approve the tariff sheet. No other responses were received.

The Commission has reviewed the tariff sheet and Staff's recommendation and finds that the tariff sheet should be approved. The Commission will approve Liberty's tariff sheet to become effective on April 21, 2024. In addition, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff sheets.
