ORDER DIRECTING RESPONSE

On March 22, 2024, Missouri Industrial Energy Consumers (MIEC) filed its application to intervene. This application was late-filed, but with no explanation of why it was late-filed. Commission Rule 20 CSR 4240-2.075(10), addressing late-filed intervention requests, states as follows:

Motions to intervene ... filed after the intervention date may be granted upon a showing of good cause. Any motion so filed must include a definitive statement whether or not the entity seeking intervention ... accepts the record established in that case, including the requirements of any orders of the commission, as of the date the motion is filed.

MIEC's application to intervene is deficient in that it does not provide a showing of good cause as to why it is late-filed, and lacks a definitive statement regarding the record established. The Commission needs these responses before it can consider MIEC's application to intervene. The Commission will set a time for MIEC to respond.

THE COMMISSION ORDERS THAT:

1. MIEC must file its response as discussed above no later than April 10, 2024.
2. This order shall be effective when issued.
