ORDER GRANTING MOTION FOR EXTENSION OF TIME TO FILE AN ANSWER

On April 4, 2024,¹ Union Electric Company d/b/a Ameren Missouri filed a motion requesting the time to file an answer to Brett Felber's amended complaint be extended. Commission Rule 20 CSR 4240-2.070(15)(A) requires Ameren Missouri to file an answer within thirty days of the order giving notice of the complaint. When an act is required by Commission rule or order to be done within a specified time, the Commission may order the period enlarged before the expiration of the period originally prescribed.² Ameren Missouri's answer is currently due on April 8.

After the complaint was voluntarily dismissed on March 19 and closed upon the Commission's acknowledgement of the dismissal that same day, Mr. Felber filed a motion to reopen the case on March 25. The Commission allowed until April 4 for responses. On April 4, Ameren Missouri requested an extension if the matter is reopened.
