ORDER APPROVING COMPLIANCE TARIFF SHEET

Issue Date: April 10, 2024

Effective Date: April 27, 2024

On February 29, 2024, the Commission issued its *Report and Order Approving Territorial Agreement* in this matter. Among other things, that order directed Union Electric Company d/b/a Ameren Missouri to submit revised tariff sheets by March 29, 2024, to reflect the change in its certificated electric service area in Adair County resulting from the order.

On March 28, 2024, Ameren Missouri filed a tariff sheet purporting to be in compliance with the terms of the Commission’s February 29th order. The new tariff sheet bears an effective date of April 27, 2024, and has been assigned Tracking No. JE-2024-0132.

At the Commission’s request, the Staff of the Commission reviewed Ameren Missouri’s tariff sheet and, on April 9, 2024, filed its recommendation that the Commission approve the tariff sheet.

Upon reviewing the pleadings, the Commission finds Ameren Missouri’s proposed revised tariff sheet complies with the Commission’s Order and will approve it. To enable

the tariff sheet to become effective on the date requested by Ameren Missouri, the Commission finds it reasonable to make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The revised tariff sheet filed on March 28, 2024, and assigned Tracking No. JE-2024-0132 is approved to become effective April 27, 2024. The approved tariff sheet is as follows:
