ORDER MODIFYING THE PROCEDURAL SCHEDULE

On April 5, 2024, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West’s (collectively “Evergy”) filed a motion to modify the procedural schedule to reschedule the submission dates for its application, non-utility direct testimony, and surrebuttal testimony. Evergy’s motion represents that the other parties, Staff and the Office of the Public Counsel, do not oppose this alteration of the schedule. The Commission will grant Evergy’s request.

THE COMMISSION ORDERS THAT:

1. The procedural schedule is modified as follows:
 - Evergy’s Application is now due April 29, 2024.
 - Non-Utility Direct Testimony is now due May 24, 2024.
 - Surrebuttal Testimony is now due August 12, 2024.

2. The remainder of the procedural schedule is unmodified.
3. This order is effective when issued.
