ORDER GRANTING APPLICATIONS TO INTERVENE

On June 4, 2018, Union Electric Company d/b/a Ameren Missouri applied to the Commission for approval of a Missouri Energy Efficiency Investment Act (MEEIA) plan. This proposed plan to be effective for the period of March 1, 2019 through December 31, 2024 includes a Demand-Side Investment Mechanism (DSIM), a Demand-Side Management Portfolio Plan, and variances from certain Commission rules. The Commission directed that all applications for intervention be filed no later than June 18, 2018. On June 6, 2018, the Midwest Energy Consumers Group filed an application to intervene. On June 7, 2018, the Tower Grove Neighborhoods Community Development Corp, the National Housing Trust, and Renew Missouri Advocates d/b/a Renew Missouri filed applications to intervene. And, on June 8, 2018, the Missouri Department of Economic Development, Division of Energy applied to intervene. More than ten days have passed since those applications to intervene were filed and no one has responded to the applications.

The Commission finds that allowing each of these organizations to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission will grant the applications to intervene.

THE COMMISSION ORDERS THAT:

1. The application to intervene of the Midwest Energy Consumers Group, the Tower Grove Neighborhoods Community Development Corp, the National Housing Trust, Renew Missouri Advocates d/b/a Renew Missouri, and the Missouri Department of Economic Development, Division of Energy are granted.
2. This order shall be effective when issued.
