## ORDER CANCELING AUTHORITY

Issue Date: April 12, 2024

Effective Date: May 13, 2024

On April 11, 2024, the Staff of the Commission (Staff) recommended the Commission to cancel the registration of BullsEye Telecom, Inc. (Company) to provide basic local telecommunications services. The Commission granted Company registration to provide basic local telecommunications service in File No. CA-2003-0113.

Staff's recommendation states that Company filed a letter on March 27, 2024 asking to cancel its certificate to provide basic local telecommunications services and all applicable tariffs. Staff recommended that the Commission cancel the Company's registration.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." The Commission issued notice and allowed time to request a hearing. The Company has not responded.

Based on Staff's recommendation, the Commission finds that the registration granted to Company shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The registration to provide basic local telecommunications service authority granted to Company in File No. CA-2003-0113 is canceled.
2. This order shall become effective on May 13, 2024.
3. This case may be closed on May 14, 2024.
