On September 17, 2018, the Office of the Public Counsel ("OPC") filed a *Motion for Evidentiary Hearing*, which requested that the Commission schedule a procedural conference to discuss a procedural schedule leading to an evidentiary hearing. OPC raised the same objections to the Staff recommendation that OPC raised in a similar previous case, File No. EO-2017-0065, which is currently on appeal at the Missouri Western District Court of Appeals in case no. WD81627. Since the parties and issues in the two cases seem to be substantially similar, it may be prudent, in the interest of administrative economy, to wait before proceeding further in this case until the Commission has received guidance from the Court in the pending appeal. The Commission will direct the parties to respond and provide a recommendation on whether the Commission should hold this case in abeyance until the Court of Appeals renders an opinion in WD81627.

#### THE COMMISSION ORDERS THAT:

1. The parties shall respond to the issue raised in this order no later than October 1, 2018.

2. This order shall become effective when issued.
