ARISTOTLE'S RESPONSE TO ORDER DIRECTING FILING (USAC AUDIT RESULTS)

Comes Now Aristotle Unified Communications Inc (Aristotle) pursuant to Commission

Order and states as follows:

- 1. On January 24, 2024, the Commission issued its Report and Order which included direction that Aristotle should file the results of the USAC audit of Aristotle within 30 days of receipt of those results. Aristotle received those results on April 4, 2024. Hence this Response is timely.
- 2. Pursuant to the Commission's Order, Aristotle submits the USAC audit results including transmission email, as confidential documents.¹
- 3. Staff recently filed a Motion to Compel alleging that Aristotle has been withholding the audit results. That allegation is incorrect. Staff's motion is based on a misunderstanding of references in previously submitted documents to communications between USAC and Aristotle during the audit, preceding Aristotle's receipt of the audit results.
- 4. Aristotle believes that USAC's audit results are based on an erroneous interpretation of law, and it plans to seek corrective action before the FCC.
