ORDER SUSPENDING TARIFF

On March 28, 2024, Union Electric Company d/b/a Ameren Missouri filed tariff sheets to extend the Charge-Ahead Business Solutions pilot program for an additional two years, due to the extended timeframes that customers need to make conversion decisions and to secure the budget to implement. Ameren Missouri's tariff sheets bear an effective date of April 27, 2024. The Commission directed its Staff (Staff) to file a recommendation about the tariff sheets.

On April 10, 2024, Staff filed a recommendation to reject the tariff sheets. Staff supports its recommendation by noting that the Commission-approved stipulation and agreement approving Charge-Ahead Business Solutions pilot program requires Ameren Missouri to file a midterm report and a final report with other specified information at the end of the initial pilot program period. Ameren Missouri has not filed that final report.

As an alternative to rejecting the tariff sheets, Staff recommends the Commission suspend the tariff sheets for Ameren Missouri to file its final report and other supporting documentation. The Commission will suspend the effective date of the tariff sheets 90

days to allow time for Ameren Missouri to file its final report and other information as specified in the stipulation and agreement.

THE COMMISSION ORDERS THAT:

1. The tariff sheets assigned Tracking No. JE-2024-0131 are suspended until July 26, 2024.
2. This order shall be effective when issued.
