On July 28, 2021, the Commission issued notice that it intended to permit the parties to work out an agreement concerning an earnings opportunity for the Pay As You Save® (PAYS®) pilot program. There have been no filings or communication with the Commission about the PAYS® pilot program since that notice was issued. The tariff sheets bear an effective date of September 13, 2021. The Commission will direct the parties to file a status report concerning whether the tariff sheets should be suspended and a procedural schedule established.

1. The parties shall file a status report no later than September 3, 2021, at 3:00 p.m.
