ORDER DIRECTING STAFF TO FILE RECOMMENDATION CONCERNING EVERGY'S COMPLIANCE FILING AND SETTING TIME FOR COMMENTS

On May 12, 2022, the Commission approved a stipulation and agreement extending Evergy Missouri Metro and Evergy Missouri West's (Evergy) Missouri Energy Efficiency Investment Act (MEEIA) Cycle 3 programs an additional year.

On June 1, 2022, Evergy filed proposed tariff revisions, Tariff Nos. YE-2022-0268 and YE-2022-0269, which bear an effective date of July 1, 2022, to comply with the Commission's order. The Commission will direct its Staff to file a recommendation informing the Commission of whether the company's tariff revisions comply with the Commission's order and the approved stipulation and agreement, and will set a time for filing other comments.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a recommendation about Evergy's compliance tariff sheets, Tariff Nos. YE-2022-0268 and YE-2022-0269, no later than June 15, 2022.

2. Any other comments about Tariff Nos. YE-2022-0268 and YE-2022-0269 shall be filed no later than June 15, 2022.

3. This order is effective when issued.
