#### ORDER MODIFYING THE PROCEDURAL SCHEDULE

On October 18, 2022, Evergy Missouri Metro and Evergy Missouri West (collectively "Evergy") filed a request to extend the procedural schedule for the purpose of continuing settlement negotiations. The Commission granted a previous request to extend the procedural schedule for the same reason.

The Commission is unable to hold an evidentiary hearing on the dates requested in Evergy's motion. The Commission will grant the extension of time for the filing of rebuttal and surrebuttal testimony, but will order Evergy to confer with the other parties and propose evidentiary hearing dates for January 2023.

The Commission will modify the procedural schedule.
