**ORDER DIRECTING NOTICE AND
SETTING A DEADLINE FOR INTERVENTION REQUESTS**

On April 18, 2024,¹ Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application requesting that the Commission approve the acquisition of the unregulated sewer assets of Barbara E. Rampone located in and around the Timber Ridge subdivision in Johnson County, MO (Timber Ridge System). The Timber Ridge System provides sewer services to five connections near the town of Knob Noster.

Currently, the Timber Ridge System customers are not charged for sewer service. Confluence Rivers proposes to use the rate currently approved for its Village of Luray service territory, which is a flat monthly charge of \$30.00.

The Commission will direct that notice be given and set a deadline for intervention requests.

4. This order shall be effective when issued.
