ORDER GRANTING EXTENSION OF TIME

On December 12, 2023, the Staff of the Commission (Staff) filed its recommendation regarding Summit Natural Gas of Missouri, Inc.'s (SNGMO's) Actual Cost Adjustment filing. SNGMO responded regarding the proposed calculation of interest for the Storm Uri balance. The parties subsequently met to discuss SNGMO's proposed method of calculating interest, and SNGMO later provided supporting materials to Staff.

Staff filed its status report on April 18, 2024, requesting an additional 30 days to further discuss and analyze the supporting materials, and to finalize discussions and develop an agreement. Staff requested that the Commission permit Staff and SNGMO to submit a stipulation/agreement no later than May 22, 2024.

The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. No later than May 22, 2024, SNGMO and Staff shall file an agreement or a further status report.
2. This order shall be effective when issued.
