On April 1, 2024,¹ the Commission issued its *Order Amending Procedural Schedule*. Among other things, the order set procedural schedule deadline dates for the filing of the Joint List of Issues and the party's Position Statements for April 29 and May 1, respectively. The order also set evidentiary hearing dates of May 7, 9, and 10.
