**ORDER GRANTING EXTENSION OF TIME**

On September 11, 2023, Joshua M. Kearney filed a complaint against Spire Missouri, Inc. d/b/a/ Spire, hereinafter Spire. The Commission ordered Complainant, Staff, and Spire to file a Procedural Schedule no later than April 12, 2024.

On April 10, 2024, Complainant filed a Motion for Extension of Time and asked for an additional thirty days to file a Procedural Schedule. On April 12, 2024 Staff filed a Status Report and an Amended Status Report asking the Commission to support Complainant’s request. On April 12, 2024, Spire filed a Procedural Schedule and opposed the Complainant’s request for a continuance.

The Commission finds the Complainant’s request for an additional thirty days to file a Procedural Schedule reasonable, and will grant it.

**THE COMMISSION ORDERS THAT:**

1. The motion for extension of time is granted.
2. Complainant and Staff shall file their Procedural Schedules no later than May 13, 2024.

3. This order shall be effective when issued.
