On April 10, 2024,<sup>1</sup> the Staff of the Commission (Staff) filed a Motion for Additional Time (Motion). Southwestern Bell Telephone Company d/b/a AT&T Missouri (Company) filed the above-referenced tariff sheet on April 1, and it bears an effective date of May 2.

Staff explains that due to the nature and timing of the conversion transaction that will occur on May 2, 2024, Southwestern Bell Telephone Company is unable to provide documents required by 20 CSR 4240-28.011(2)(A)2. Thus, Staff asks for the Commission for additional time to complete and file its recommendation. The Company's response was filed April 15, stating it did not object to an extension.

The Commission finds Staff's Motion reasonable. Therefore, the Commission will extend Staff's time to file a recommendation.
