On March 13, 2024, Liberty Utilities (Missouri Water) Corp. d/b/a Liberty filed tariff sheets and testimony initiating a rate case to increase its annual water and sewer revenues. The City of Bolivar, Missouri, and Holiday Inn Club Vacations, Inc. filed applications to intervene. Ten days have elapsed, and no party has objected to the applications to intervene.¹ The applications satisfy the requirements of Commission Rule 20 CSR 4240-2.075 and intervention will be granted.

THE COMMISSION ORDERS THAT:

1. Holiday Inn Club Vacations, Inc.'s application to intervene is granted.
2. The City of Bolivar's application to intervene is granted.
3. This order shall be effective when issued.
