ORDER PROVIDING NOTICE, ORDER ESTABLISHING INTERVENTION DATE, ORDER ESTABLISHING TIME FOR RESPONSE, AND ORDER DIRECTING STAFF RECOMMENDATION

On April 1, 2024, The Empire District Electric Company d/b/a Liberty asked the Commission to grant it variances from certain requirements of the Commission's Integrated Resource Planning Rule, 20 CSR 4240-22.030(4)(A)(1). The Commission will allow time for potentially interested parties to apply to intervene, and will order a Staff Recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to all parties to Liberty's previous integrated resource planning case, EO-2021-0331.
2. Any application to intervene shall be filed no later than May 14, 2024.
3. The Staff of the Commission shall file a recommendation with regard to the request for variance or, in the alternative, a status report stating when it plans to file its Recommendation, no later than May 16, 2024.
4. Any other responses to the request for a variance shall be filed no later than May 16, 2024.
5. This order shall become effective when issued.
