ORDER DENYING LATE-FILED APPLICATION TO INTERVENE

On March 6, 2024,¹ the Commission ordered that applications for intervention would be due no later than March 21. On March 22, Missouri Industrial Energy Consumers (MIEC) late-filed its application to intervene. On April 5, the Commission ordered a response from MIEC, due April 10, to explain the lateness.

No response from MIEC was received.

Late-filed applications to intervene are governed by Commission Rule 20 CSR 4240-2.075(10). It states that late-filed applications to intervene may be granted upon a showing of good cause. Without a reply from MIEC offering an explanation, the

Commission cannot make a finding of good cause being shown for the late-filing. Thus, the application to intervene of MIEC is denied.
