The Commission has undertaken this rulemaking to amend its rules regarding building codes for modular units. The proposed amended rule updates recent editions of the building codes and updates out-of-date references to the Code of State Regulations.

The Commission finds that the rule is necessary to protect the public interest and to carry out the purposes of the statute that granted the rulemaking authority. The Commission will seek further comments from interested stakeholders during the rulemaking process.

THE COMMISSION ORDERS THAT:

1. The Secretary of the Commission shall file the proposed rule with the Secretary of State for publication in the Missouri Register as a proposed rulemaking.
2. This order shall be effective when issued.
