ORDER DIRECTING RECOMMENDATION ON REVISED TARIFF

Issue Date: April 24, 2024

Effective Date: April 24, 2024

On April 24, 2024, the Commission issued an *Order Approving Infrastructure System Replacement Surcharge (ISRS)* in this matter, to be effective on May 4, 2024. The order granted Spire Missouri Inc. d/b/a Spire authority to change its ISRS, rejected Spire’s tariff sheet filed on January 17, 2024, and authorized Spire to file new tariff sheets to recover the revenues authorized by the order.

On April 24, 2024, Spire filed a revised tariff sheet, bearing an effective date of May 24, 2024, and assigned Tracking No. JG-2024-0103, purporting to comply with the terms of the Commission’s April 24th order. In addition, on April 24, 2024, Spire filed a *Motion for Expedited Treatment*, asking for approval of the revised tariff sheet to become effective on May 8, 2024, if practical.

The Commission will ask its Staff to file an expedited recommendation advising the Commission as to whether the submitted revised tariff sheet complies with the Commission’s April 24th order.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding Spire’s revised tariff sheet (Tracking No. JG-2024-0103) no later than May 2, 2024.

2. This order shall be effective when issued.
