PROPOSED LOCAL PUBLIC HEARING LOCATIONS

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), by and through counsel, and on behalf of itself and the Office of the Public Counsel ("OPC"), submits these proposed public hearing locations:

1. On March 13, 2024, Liberty Utilities (Missouri Water) LLC d/b/a Liberty filed

its request for a rate increase for its water and wastewater service areas in Missouri.

2. On March 15, 2024, the Commission filed its Order Giving Notice, Setting a

Deadline to Intervene, Setting a Deadline to Respond to the Test Year, and Directing a

Proposed Schedule. Among other requirements the *Order* directed the filing of a proposed procedural schedule including local public hearings.

3. Staff, Liberty, the Office of Public Counsel... were able to reach agreement on all aspects of the proposed procedural schedule except the appropriate number of local public hearings.

4. Due to the rate impact associated with the requested increase,¹ Staff anticipates significant public interest. Early press coverage associated with just one of Liberty's twenty-nine (29) service areas has generated over 270 public comments for this case already. Once customer notices are generated Staff anticipates a much greater

interest. Because of this anticipated level of participation, the number of distinct systems, the distance between many of the communities served by Liberty, and the rural setting of these communities, a large number of local public hearings is necessary.

5. Staff proposes the following local public hearing locations:

- Pacific
- Cape Girardeau
- Poplar Bluff
- Branson
- Republic
- Bolivar (2)²
- Noel

6. In addition to the local public hearings listed above, Staff recommends two virtual public hearings.³

WHEREFORE, on behalf of itself and OPC, Staff respectfully proposes that the

Commission accept Staff and OPC's proposed local public hearing locations, and grant

any such other and further relief as is just under the circumstances

³ There is a concern regarding access to reliable internet sufficient to attend a virtual local public hearing for some of Liberty's service territory. Therefore, Staff and the OPC suggest holding virtual local public hearings only in addition to the in-person local public hearings identified above.
