ORDER DIRECTING COMPLAINANT TO SHOW CAUSE WHY COMPLAINT SHOULD NOT BE DISMISSED

Issue Date: April 25, 2024 Effective Date: April 25, 2024

On January 25, 2024,¹ Brett Felber filed a Formal Complaint against Union Electric Company d/b/a Ameren Missouri (Ameren Missouri). Then on March 9, Mr. Felber filed a Motion to Amend Complaint to "include new recently given data." After briefly dismissing the complaint voluntarily on March 19, Mr. Felber filed a Motion to Reopen the Case on March 25. On April 22, Ameren Missouri timely filed a Motion to Dismiss Mr. Felber's Amended Complaint based on the doctrine of *res judicata*.²

The phrase *res judicata* means "a matter judged." Missouri courts typically prohibit relitigating matters.³ This includes additional evidence used to support a claim.⁴ Through claim preclusion, a motion to dismiss based on *res judicata* is a motion to dismiss for failure to state a claim on which relief may be granted. Per Commission Rule 20 CSR 4240-2.070(7), "The commission…on the motion of a party, may after notice dismiss a complaint

for failure to state a claim on which relief may be granted...or may strike irrelevant allegations" The Commission will order Mr. Felber to file a pleading showing cause as to why his complaint should not be dismissed.

THE COMMISSION ORDERS THAT:

- 1. Complainant Brett Felber shall file a pleading no later than June 14, 2024, showing cause why his complaint against Ameren Missouri should not be dismissed for failure to state a claim on which relief may be granted.
 - 2. This order is effective when issued.
