I wanted to give you another update on progress of customer restoration in Mississippi County.

- Equipment is onsite and crews are working on the conductor repairs and wreck out of damaged line
- Poles are onsite and the rest of the material is arriving as of 4:00 p.m. today.
- We have a crew on standby for softdig if needed for any issues with the excavations
- We have sufficient lighting onsite and weather/wind are not anticipated to be an issue
- We will continue to communicate to customers that we anticipate restoration before noon tomorrow.
