## ORDER SHORTENING TIME FOR RESPONSES

On April 24, 2024,<sup>1</sup> the Commission issued an *Order Directing Recommendation* on *Revised Tariff*, in which the Staff of the Commission (Staff) was directed to file a recommendation, no later than May 2 on Spire Missouri Inc. d/b/a Spire's revised tariff sheet, filed on April 24, and assigned Tracking No. JG-2024-0103. Spire also requested expedited treatment so that its tariff sheet could become effective on May 8.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless otherwise ordered by the Commission. In order to leave open the possibility of Commission approval of the revised tariff sheet by the May 8<sup>th</sup> date requested by Spire, the Commission will shorten the time for other parties to respond to the tariff sheet and motion for expedited treatment.

#### THE COMMISSION ORDERS THAT:

- 1. Any responses to Spire's revised tariff sheet (Tracking No. JG-2024-0103) and its motion for expedited treatment shall be filed no later than May 2, 2024.
  - 2. This order shall be effective when issued.
