## ORDER CANCELING AUTHORITY

Issue Date: April 29, 2024

Effective Date: May 29, 2024

On April 26, 2024, the Staff of the Commission (Staff) recommended the Commission to cancel the registration of BullsEye Telecom, Inc.'s (Company) to provide interconnected voice over internet protocol (IVoIP) services. The Commission granted Company registration to provide IVoIP service in File No. DA-2009-0427.

Staff's motion states that Company filed a letter on April 12, 2024 asking to cancel its certificate to provide IVoIP services and all applicable tariffs. Staff recommended that the Commission cancel the Company's registration.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the registration granted to Company shall be canceled.

### THE COMMISSION ORDERS THAT:

1. The registration to provide interexchange telecommunications service authority granted to Company in File No. DA-2024-0427 is canceled.

2. This order shall become effective on May 29, 2024.
3. This case may be closed on May 30, 2024.
