On March 25, 2024, the Staff of the Commission (Staff) filed a complaint against Spire Missouri Inc. d/b/a Spire alleging violation of certain sections of the Commission's gas safety rules.

On March 28, 2024, the Commission issued a *Notice of Complaint and Order Directing Answer* in which Spire was directed to file an answer to the complaint no later than April 29, 2024.

On April 22, 2024, Spire filed a *Request for Additional Time to File an Answer or Status Update*, in which it asks for additional time to have discussions with Staff that could potentially reach agreement on a number of issues and recommendations raised by Staff. Staff does not oppose Spire's request.

The Commission will grant Spire's request.

THE COMMISSION ORDERS THAT:

1. Spire's request for additional time to file an answer to Staff's complaint is granted.

2. Spire shall file an answer to the complaint, or a status report, no later than June 3, 2024.
