## **ORDER GRANTING EXTENSION OF TIME**

On May 19, 2023, Spire Missouri Inc. d/b/a Spire filed an application requesting a variance from the Resale Provision of its Tariff Rules and Regulations. The Staff of the Commission (Staff) was directed to file a recommendation. Staff requested authority to seek a formal interpretation of the federal rule from the Pipeline and Hazardous Materials Safety Administration (PHMSA), and, upon the granting of prior extensions, was directed to file its recommendation or a status report no later than April 30, 2024.

On April 26, 2024, Staff filed a status report, and requested an extension to file its recommendation to June 28, 2024. Staff states it has not yet received a response from PHMSA to complete its recommendation. The Commission finds this request reasonable and will grant it.

## THE COMMISSION ORDERS THAT:

1. Staff shall submit its recommendation or status report no later than June 28, 2024.

2. This order shall be effective when issued.
