ORDER DIRECTING FILING OF REPORTS

On April 18, 2024, the Staff of the Commission filed its ninth status report providing a summary of the City Utilities of Springfield's plastic pipe replacement program. Staff explained that the City Utilities has provided its monthly updates to Staff for calendar years 2021, 2022, and 2023, but Staff has not received the monthly updates for January 2024, February 2024, and March 2024. Further, Staff explained it has not received the City Utilities' semi-annual reports for the periods of April 1, 2022 through September 30, 2022; October 1, 2022 through September 30, 2023; and October 1, 2023 through March 31, 2024.

Staff stated that it and the City Utilities have agreed that the delinquent semi-annual reports should be provided as one report. As part of Staff's ninth Status Report, Staff asks the Commission to order the City Utilities to provide the aforementioned combined report and monthly reports by no later than May 17, 2024. After the reports are received, Staff will review the reports for consistency with the results provided by the City Utilities.

The Commission will order the City Utilities to file its reports as requested by Staff.

THE COMMISSION ORDERS THAT:

1. The City Utilities shall provide the combined report and monthly reports as discussed above no later than May 17, 2024.
2. This order shall be effective when issued.
