# ORDER DIRECTING RESPONSE REGARDING LOCAL PUBLIC HEARING

On April 18, 2024, TBJ Sewer Systems, Inc. filed a letter requesting an increase in its annual sewer system operating revenues in a staff assisted rate case under Commission Rule 20 CSR 4240-10.075. Subsection 6 of the rule requires a local public hearing to be scheduled to occur no later than 60 days after the opening of the case unless all parties agree that a local public hearing is not necessary. In this case, that deadline is June 17, 2024.

The Commission will direct the parties to file a response recommending locations and dates for a local public hearing or that a local public hearing is not necessary.

#### THE COMMISSION ORDERS THAT:

- 1. No later than May 7, 2024, Staff shall consult with the parties in this case and shall file a joint response, either listing recommended dates and locations for a local public hearing, or notifying the Commission that a local public hearing is not necessary.
  - 2. This order shall be effective when issued.
