## MOTION TO REJECT TARIFF SHEETS

COMES NOW the Office of the Public Counsel and for its Motion to Reject Tariff Sheets states as follows:

- 1. On May 24, 2007<sup>1</sup> Aquila, Inc. filed yet another set of tariff sheets in its attempt to create tariffs that comply with the Commission's Report and Order. The four tariff sheets filed on May 24 bear an issue date of May 21 and an effective date of June 20.
- 2. On May 18, Aquila had filed its first set of tariff sheets that were intended to comply with the Report and Order. On May 21, Aquila withdrew its May 18 tariff sheets, and filed its second set of tariff sheets. In its cover letter accompanying the second set of tariff sheets, Aquila stated: "Because those tariff sheets bore an effective date less than thirty (30) days from the date of issuance, Aquila filed new tariff sheets earlier today to correct that error."
- 3. In its May 24 tariff filing Aquila tries to avoid making the same error by "backdating" the issue date of its May 24 tariff filing to show an issue date of May 21. A tariff filing made on May 24 cannot have been issued on May 21.

4. Section 393.140(11) requires 30 days notice of tariff changes. Simply backdating the date of issuance to a date before filing, notice and publication cannot make the period between May 24 and June 20 thirty days. The Commission should reject the May 24 tariff filing.

WHEREFORE, Public Counsel respectfully requests that the Commission reject the tariff sheets filed on May 24, 2007.
