1. On April 18, 2024, Confluence Rivers filed an *Application and Motion for Waiver* requesting that the Commission approve the acquisition of the unregulated sewer assets of Barbara E. Rampone located in and around the Timber Ridge subdivision in Johnson County, MO (Timber Ridge System).


2. After discussion with the Staff of the Commission, Confluence Rivers seeks to supplement its Application with the Engineering Memorandum applicable to Timber Ridge.


