**ORDER GRANTING EXTENSION OF TIME  
TO FILE STAFF RECOMMENDATION**

On March 22, 2024,<sup>1</sup> Spire Missouri Inc. (Spire) filed an application requesting a certificate of convenience and necessity to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide natural gas service in Newton County, Missouri, as a further expansion of Spire’s existing certificated area.

On March 25, the Commission issued an order that, among other things, directed the Staff of the Commission (Staff) to file a recommendation regarding Spire’s application by May 9, or to file a request for an extension of time.

On May 3, Staff filed its *Motion for Extension of Time to File Staff Recommendation* requesting an additional 30 days to complete its investigation and file its recommendation. Neither Spire nor the Office of the Public Counsel object to Staff’s motion.

The Commission will grant the motion.
